**MEMORANDUM OF UNDERSTANDING  
BETWEEN MHMR AND TOM GREEN COUNTY**

THIS Memorandum of Understanding (MOU) is entered into between MHMR Services for the Concho Valley established and operated as a Community MHMR Center pursuant to Section 534 Subchapter A, Health and Safety Code and designated as a local MHMR authority pursuant to Section 534 Subchapter B, Health and Safety Code (hereinafter referred to as "Center"), and Tom Green County Commissioner's Court (hereinafter referred to as "County")

**I. STATEMENT OF UNDERSTANDING:**

In consideration of receiving a Crisis Redesign general revenue allotment from the Center, the County will:

1. Hire one additional Mental Health Deputy to complement the existing MHD program.
2. In coordination with the newly formed MHMR Mobile Crisis Outreach Team (MCOT), the County will develop and offer Governmental Interlocal Agreements with all counties (Coke, Concho, Crockett, Irion, Reagan, Sterling, and Tom Green ) served by the Center whereby a team of one Mental Health Deputy and one MCOT worker will respond to MH crisis calls originating in any of the seven counties.
3. The County will provide for the transportation needs of the new Mental Health Deputy.
4. The Center will provide for the transportation needs of the MCOT worker.

**II. DISTRIBUTION OF ALLOCATION:**

The grant will be distributed quarterly, in the sum of \$12,000 for each quarter, upon the Center's receipt of a properly presented invoice from the County. A total grant of \$36,000 is allotted to the County.

**III. TERM OF AGREEMENT:**

This MOU is to begin January 1, 2008 and shall terminate September 30, 2008.

**IV. RELATIONSHIP OF PARTIES**


- A. The Center is associated with the County only for the purposes and to the extent set forth herein with respect to the performance of the Memorandum of Understanding. Nothing contained herein shall be deemed or construed to create a partnership or joint venture, nor to create the relationships of an employer-employee or principal-agent, or to otherwise create any liability for either party whatsoever with respect to liabilities and obligations of the other party.
- B. The Center hereby designates Charles Vandiver, or his designee as the responsible person for the program. The County hereby designates Commissioner Steve Floyd, or his designee, to serve as the liaison for implementation of this MOU.

**V. MISCELLANEOUS**


- A. Either party may terminate this MOU, without cause, upon thirty (30) days prior written notice to the other party.
- B. This MOU and any written modifications constitute the sole agreement of the parties. Any oral agreements or understandings outside the terms of this MOU shall be void.
