ORDER APPOINTING AUDITOR FOR TOM GREEN COUNTY


Pursuant to Local Government Code §84.003, the District Judges of the 51st, 119th, 340th and 391st Judicial District Courts of the State of Texas hereby appoint Corey Nathan Craddock as Auditor for Tom Green County, Texas. Corey Nathan Craddock is appointed for a 2 year term of office beginning March 22, 2008 and ending March 21, 2010. The Auditor's salary has been established by a prior order of the Courts held August 23, 2007.

Pursuant to Local Government Code §84.003, the "clerk of the district court shall record the judges' action in the minutes of the court and certify it to the commissioners court. The commissioners court shall record in its minutes the judges' action and an order directing the payment of the auditor's salary."





**ORDER SETTING CERTAIN SALARIES


