Summary: The subject property was auctioned in December 1999, with no offers received. Subsequently, the property was struck off to the City as Trustee for itself and the other taxing entities.

The size of the lot is 60' x 150' and is located on Tarver St., next to 717 Tarver St.

The City has received an offer from Salvador Pena Sosa, a single person, in the amount of \$1,500.00 for the purchase of the property. This offer will satisfy all the court costs and more than half of the taxes.

Lot 4 and the East 10 ft. of Lot 3, Block 2, Spencer Addition #3, City of San Angelo, as shown by Plat thereof recorded in the office of the County Clerk of Tom Green County, Texas.

Purchase Price:

Buyer will purchase the Property for the sum of One Thousand Five Hundred and NO/100 Dollars (\$ 1,500.00)

Tax Warrant:

The Tax Warrant for the foreclosure of a tax lien against the Property entered on October 26, 1999 in Suit No. B-97-0134-T by the 119th District Court of Tom Green County, Texas.

Sheriff's Deed:

Sheriff's Tax Deed dated January 5, 2000, filed of record on January 6, 2000, and recorded in Suit No. B-97-0134-T of the Official Public Records of Real Property, Tom Green County, Texas.

WHEREAS, the City of San Angelo, a Texas home rule municipal corporation, acquired full legal title to the Property — both for its own benefit and as Trustee for all other taxing authorities entitled to receive proceeds from the sale of the Property under the terms of the Judgment — by the Sheriff's Tax Deed.

WHEREAS, Tom Green County, a political subdivision of the State of Texas, is one of the taxing authorities entitled to receive proceeds from the sale of the Property under the terms of the Judgment.

WHEREAS, the City of San Angelo now desires to sell the Property to Buyer, and Buyer desires to purchase the Property from the City of San Angelo, in a private sale for the Purchase Price, an amount that is less than the lesser of (1) the market value specified in the Tax Warrant or (2) the total amount of the Judgment.

WHEREAS, Texas Tax Code §34.05(i) requires that Tom Green County consent to any sale of the Property upon such terms; and

WHEREAS, Tom Green County desires to consent to the sale of the Property to Buyer as proposed by the City of San Angelo and Tom Green County makes this Certificate of Resolution

for the purpose of evidencing Tom Green County's resolution to consent to the sale of the Property to Buyer for the Purchase Price;

NOW, THEREFORE, the Commissioners of Tom Green County convened on 1-19-2010, ~~2009~~, for its regularly-scheduled meeting, following proper notice and agenda posting as required by law. At such meeting, the commissioners fully discussed and considered the sale of the Property to Buyer. Following a full evaluation of the matter and review of the proposed sale, upon motion duly made, seconded and unanimously carried, it was:

RESOLVED, that Tom Green County Commissioners authorizes the City of San Angelo to sell the Property to Buyer for the Purchase Price, in accordance with §34.05(i) of the Texas Tax Code;

and further,

RESOLVED, that Judge Brown, Judge of Tom Green County, is hereby authorized and directed to execute any and all instruments on behalf of Tom Green County that may be appropriate or necessary to effectuate the sale of the Property to Buyer as contemplated herein.
