



In accordance with Government Code Section 52.051 and Local Government Code Section 152.905, the salary of Lori G. Dobbins as Official Court Reporter of this Court is set at \$65,812.00 per year effective October 1, 2011. The salary shall be paid monthly by the three counties comprising the 119th Judicial District of Texas and shall be prorated according to population as follows.
