Amendment No. 16 to Operating Agreement

THIS AMENDMENT NO. 16 (the "Amendment") is entered into this 20 day of March, 2012 by and between **Tom Green County, Texas** (the "County"), and **ARAMARK Correctional Services, LLC**, a Delaware limited liability company having its principal place of business located at the ARAMARK Tower, 1101 Market Street, Philadelphia PA 19107 ("ARAMARK").

WHEREAS, the County and ARAMARK entered into an Operating Agreement dated February 23, 1999 for the management of the food service operation at the Tom Green County Correctional Facility (as amended, the "Agreement"); and

WHEREAS, the parties desire to amend the provisions of the Agreement as follows, effective March 1, 2012.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below. Capitalized terms used but not defined in this Amendment have the meanings ascribed to such terms in the Agreement.

1. **Term:** The term of this Agreement shall be renewed for one (1) additional month effective as of March 1, 2012. Thereafter, the Agreement shall automatically renew for additional one (1) month periods until terminated by either party.
2. Except as set forth herein, all other terms and provisions of the Agreement shall remain unaffected by this Amendment and continue in full force and effect.
