ON 05/07/2012, AT APPROXIMATELY 8:27AM, I WAS DISPATCHED TO 11775 NORTH GRAPE CREEK ROAD, IN REFERENCE TO A REPORT OF THEFT THAT HAD OCCURRED AT THAT LOCATION.

UPON MY ARRIVAL AT THE LOCATION, I MET WITH THE COMPLAINANT NELSON PEREZ.

N. PEREZ ADVISED ME THAT HE IS AN EMPLOYEE OF TOM GREEN COUNTY, ASSIGNED TO THE TOM GREEN COUNTY PARKS DEPARTMENT.

N. PEREZ ADVISED ME THAT THE THE PROPERTY AND EQUIPMENT LOCATED AT 11775 NORTH GRAPE CREEK ROAD, SAN ANGELO, TEXAS 76901, BELONGS TO THE TOM GREEN COUNTY PARKS DEPARTMENT.

N. PEREZ ADVISED THAT HE IS ASSIGNED TO WORK AT THE LOCATION AND THAT WHEN HE LEFT THE LOCATION ON FRIDAY, 05/04.2012, AT APPROXIMATELY 5:00PM, THAT HE LOCKED AND SECURED THE AREA, ALONG WITH A TRAVEL TRAILER THAT IS LOCATED ON THE PROPERTY WHICH IS UTILIZED AS AN OFFICE FACILITY.

N. PEREZ ADVISED ME THAT WHEN HE ARRIVED FOR WORK THIS MORNING AT APPROXIMATELY 8:00AM, HE NOTICED THAT THE METAL HINGED AFFIXED TO THE OUTSIDE PORTION OF THE LEFT SIDE DOORWAY ENTRANCE TO THE TRAILER, AND THE SECURITY LOCK USED TO SECURE THE DOOR, APPEARED TO HAVE BEEN PRYED OPEN AND BROKEN OFF, ALLOWING FOR ENTRY INTO THE TRAVEL TRAILER.

N. PEREZ SAID THAT HE OBSERVED THAT THE CONTENTS OF THE TRAVEL TRAILER APPEARED TO HAVE BEEN STREWN ABOUT THE INSIDE OF THE TRAILER, AND THAT A SONY BRAND VCR/DVR RECORDER THAT WAS LOCATED INSIDE THE TRAVEL TRAILER, WAS TAKEN FROM THE FRONT COUNTER TOP AREA WHERE IT WAS KEPT BENEATH A SECURITY SURVEILLANCE TV MONITOR.

N. PEREZ SAID THAT HE DID NOT OBSERVE ANY OTHER ITEMS MISSING FROM INSIDE THE TRAVEL TRAILER, BUT OBSERVED THAT SOME MISCELLEOUS HAND

TOOLS SUCH AS RATCHET SETS AND WRENCHES WERE MISSING FROM A METAL STORAGE CONTAINER ALSO LOCATED ON THE PROPERTY.

N. PEREZ SAID THAT HE DID KNOW THE VALUE OF THE ITEMS TAKEN, OR THE SERIAL NUMBER OF THE VCR/ DVR RECORDER.

N. PEREZ ADVISED THAT HE BELIEVED THAT THE SURVIELLANCE EQUIPMENT WHICH INCLUDED THE VCR/DVR RECORDER, A VIDEO CAMERA, AND TELEVISION MONITOR, WAS PURCHASED BY TOM GREEN COUNTY FOR APPROXIMATELY \$5000.00.

N. PEREZ ADVISED THAT NO ONE HAD PERMISSION TO ENTER ONTO THE PROPERTY OR INTO THE TRAVEL TRAILER OR TO TAKE ANY OF THE ITEMS FROM THE PROPERTY.

I TOOK PHOTOGRAPHS OF THE HINGE LOCK DEVICE AND DOOR DAMAGE, WHERE ENTRY APPEARED TO BE MADE INTO THE TRAILER, THE COUNTER AREA WHERE N. PEREZ ADVISED THE VCR/DVR RECORDER HAD BEEN LOCATED, AND OF THE CONTAINER WHICH N. PEREZ ADVISED THAT THE TOOLS WERE TAKEN FROM, ALL OF WHICH HAVE BEEN INCLUDED WITH THIS REPORT.

THE LOCKED GATED ENTRANCE TO THE PROPERTY ALLOWING VEHICLE ACCESS WAS NOT BREECHED OR OPEN UPON N. PEREZ'S ARRIVAL AT THE LOCATION, AND NO OTHER ITEMS APPEARED TO BE MISSING.

On 04-22-12 I was advised by Deputy Collier, Lindsey that a person (s) broke into her patrol car. Lindsey advised me that her boyfriend Shawn Bryan called her advising her that her vehicle was broken into. Lindsey advised me that all the windows were broken out of unit 524, all the tires were slashed and her shotgun was stolen out of her unit. I then asked dispatch to call Lt. Faison to advise him of what happened. Dispatch advised me that Lt. Faison asked to call SAPD Officer Tinsley badge #9004 to the scene at 121D Maryland St. to investigate the theft of Firearm and (Burglary of a Vehicle).

I then travelled over to 121D Maryland St. to secure the scene. Upon arriving to 1211D Maryland St. I observed that unit #524 had a right front flat tire, the driver window was shattered and I looked in the unit and observed that the shotgun was missing. I then met with SAPD Officer Tinsley and he advised me that he called his CSI investigator to the scene to process the vehicle. I then asked Shaun Bryan if he could right me a statement of fact, which I turned in with this report.

Shaun advised me that he observed the patrol car sitting out front last night around 9:15pm when he arrived at 121D Maryland St. which is his girlfriend's house. Shaun stated he spent the night there in Officer Colliers house but did not hear anything during the night. Shaun advised me that he called Deputy Collier and told her about the break in on her unit. Shaun stated Deputy Collier told him to check and see if her key to the unit was still in the center console. Shaun stated he opened the driver door, opened the center console flap and retrieved a key on a key ring. Shaun stated he also tried getting the rifle out of its lock but he could not open the lock.

Shaun advised me that the neighbor across the street came over and told him about the break in on unit #524. Deputy Sanchez spoke to Ernesto Cardenas who lives across the street at 124 Maryland. Deputy Sanchez was advised by Ernesto after seeing the damage he made contact with Shaun and told him of the damage. Ernesto stated he came outside at about 8:00am on 04-22-12 and observed the damage to Deputy Collier's unit. While at the scene a female who lives a street down from Maryland stopped to report to Officer Tinsley that a person (s) broke into her vehicle and stole her purse.

Upon SAPD CSI (Chris Clements) arrival he began processing the vehicle. Upon the CSI finishing with the processing of the vehicle he released the vehicle to me. I then asked Deputy Sanchez to drive the unit over to the county shop to prevent further criminal mischief to the unit. Upon arrival Mark Horner who is the shop foreman drove the unit inside the shop to secure it. I
