AGREEMENT TO HOUSE INMATES

This agreement is made and entered into by and between Tom Green County and Tom Green County Sheriff and the undersigned Sterling County Judge and Sterling County Sheriff and voids all previous agreements between Tom Green County and Sterling County, Texas **WITNESSETH:**

WHEREAS, Sterling County desires to house and provide beds at the Tom Green County Jail for inmates in the custody of Sterling County; and

WHEREAS, Tom Green County, when space is available, has space and beds in the Tom Green County Jail to house inmates from Sterling County; and

WHEREAS, all inmates from Sterling County shall be housed and beds furnished in the Tom Green County Jail in accordance with a Jail Plan approved by the Texas Commission on Jail Standards.

TERMS AND CONDITION

1. Tom Green County Jail may house any amount of inmates for Sterling County as bed space is available, at the discretion of the Sterling County Sheriff or his successor in office.
2. The following consideration shall be paid to Tom Green County for each day or part thereof of each inmate held in the Tom Green County Jail:

\$42.00 for each ADULT MALE inmate
\$42.00 for each ADULT FEMALE inmate

3. No juveniles may be housed in the Tom Green County Jail, unless the inmate has been certified as an adult.

4. The expense of any prescription medications, emergency care, and other medical needs of any inmate shall be the responsibility of Sterling County. Tom Green County shall provide certain non-prescription medications for inmates at no cost to Sterling County. However, Tom Green County Jail reserves the right to charge a small fee to any inmate for non-prescription medication and medical services rendered, ie.....facility nurse. Notification will be made to Sterling County prior to any appointment being made for any inmate to see any physician of the facility Doctor. Any inmate requiring emergency medical care will be transported to Shannon Medical Center at Sterling County's expense. Notification will be given to Sterling County as soon as feasible.
5. Transportation to and from Tom Green County Jail of inmates of Sterling County will be the primary responsibility of Sterling County.
6. Should an inmate become disruptive or cause a disturbance while housed in the Tom Green County Jail, contact will be made with Sterling County and removal or exchange for another inmate will be primary responsibility of Sterling County.
7. Tom Green County reserves the right to screen all inmates from Sterling County for communicable diseases. Tom Green County reserves the right to refuse to house any inmate of Sterling County if the inmate has or is suspected to have a communicable disease.
8. Sterling County shall contact Tom Green County Jail prior to transporting inmates to the Tom Green County Jail.
9. Inmates of Sterling County shall be required to abide by all policies, procedures and regulations of the Tom Green County Jail.
10. Sterling County shall provide a complete Texas Uniform Health Status Update form at the time Tom Green County accepts custody of any inmate from Sterling County other than an initial arrest. An Inmate Intake Sheet shall be furnished to Tom Green County upon the arrival of any inmate on an initial arrest.

11. All payments made pursuant to this Agreement shall be received no later than the 10th day of the month following the month in which services were rendered, or pursuant to other arrangements made between Tom Green County and Sterling County which are mutually agreeable. Payments shall be made to:

12. This agreement shall be construed as a continuing contract, binding on Tom Green County and Sterling County as to the terms and conditions herein shown. This Agreement may be terminated by either party upon (1) one day written notice, by fax or US mail, to the Sheriff or County Judge of either County.
