Pursuant to Occupations Code to Section 1704.0535. ELECTION OF BAIL BOND SURETY BOARD MEMBER.

(a) The board shall annually conduct a secret ballot election to elect the member of the board who serves as the representative of licensed bail bond sureties by electing a licensed bail bond surety or agent for a corporate surety board member.

(b) Each individual licensed in the county as a bail bond surety or agent for a corporate surety is entitled to cast one vote for each license held.

A locked ballot box will be available December 13th during 8:00 a.m. to 2:00 p.m. in the Elections office, located on the 2nd floor of the Edd B Keyes Building, 113 West Beauregard, San Angelo, Texas.

Ballots will be provided to the agents at the Elections Office. Agents will need to show their Bail Board Identification to receive their ballot.

The ballot box will be opened during the Bail Bond Board Meeting held on December 13, 2012 and votes will be counted at that time.


