

**RESOLUTION**

**WHEREAS:** In 1930, the D.M. Arnolds' donated an acre of land to the County Judge of Tom Green County and his successors in office of the County of Tom Green, State of Texas. The purpose and use of the donated land was stated as a graveyard for the Water Valley Community. In 1946, the W.S. Armstrongs' donated an adjoining acre to the previous acre of the Water Valley Cemetery. In 2000, Bill V. David donated by Quit Claim Deed, 1.341 acres, more or less. That land adjoins the first two (2) acres for a total of 3.341 acres more or less, and;

**WHEREAS:** January 24, 1994, the Tom Green County Commissioners Court approved the appointment of an Advisory Board for the Water Valley Cemetery, and;

**WHEREAS:** The Water Valley Cemetery Advisory Board shall be authorized to conduct the everyday affairs of the cemetery, allocate space, provide for the upkeep of the spaces and markers, and to accept in trust and expend funds donated to the Water Valley Pioneer Cemetery, and;
