In April 2009, Shannon Medical Center revised its Charity Care Policy to better serve the needs of the low income patients in Tom Green County. Shannon wanted to provide a report to the County to illustrate the service impact of this policy change.

Tom Green County Indigent Care Patients have received services through Shannon in the following areas:
