Dear JoAnn:

Good morning, and Happy Neil Armstrong's Birthday.

Texas.gov has been informed about a few jurisdictions scheduling their conversion from Texas.gov eFiling to TexFile. As each jurisdiction's conversion to TexFile is scheduled, there are a few considerations from the 118th Annual CDCAT Conference to which we would like to call your attention. Below are some items to remember from the presentation.

- **Refunds** – It is possible for each jurisdiction to initiate a refund through TPE up to one (1) year after the original transaction. Should a jurisdiction choose to process a refund, the refund will debit directly from the jurisdiction's bank account. Please review the bank account currently receiving eFiling credits, and insure it is enabled to support eFiling debits. Jurisdiction personnel will retain access to TPE for one year after the jurisdiction is converted to TexFile.
- **Chargebacks** – It is possible for jurisdiction constituents to initiate a chargeback up to one (1) year after the original transaction. Should a chargeback be initiated, the funds will debit from Texas.gov's bank account. Texas.gov will generate an invoice to the jurisdiction for reimbursement of the chargeback.
- **PCI SAQ** – Since refunds and chargebacks can process up to one (1) year after the original transaction, a PCI SAQ form will be needed from each jurisdiction one (1) year after the last transaction for that jurisdiction processes. If the jurisdiction anniversary date is 11/1/2013, and the last transaction is 12/1/2013, a PCI SAQ will be needed through 11/1/2014. If the jurisdiction anniversary date is 12/15/2013, and the last transaction is 12/1/2013, a PCI SAQ will NOT be needed in 2014. Texas.gov will continue to alert each impacted jurisdiction approximately four (4) months prior to their anniversary date. Please know, the PCI SAQ being completed for Texas.gov and eFiling is specific to transactions that process through Texas.gov. Please speak with the TexFile service provider about PCI requirements related to TexFile transactions.

Requesting Conversion - When a jurisdiction decides to schedule conversion to TexFile from eFiling, please update the below correspondence with jurisdiction specific information. An official communication is requested to be mailed to both Texas.gov Contracts Department, and the Department of Information Resources (DIR). Below is sample text of the communication a jurisdiction may provide on jurisdiction letterhead when converting to TexFile, and terminating Texas.gov eFiling services.

Filings submitted on the conversion date, even after 5:00 p.m., will need to be disposed, and final jurisdiction close-out reports generated prior to 11:59 p.m. that day.
