

Amendment No. 2 to Operating Agreement – Food Service

THIS AMENDMENT NO. 2 is entered into this 4 day of November 2014 by and between Tom Green County, a legal and political subdivision of Texas (the "County") and ARAMARK Correctional Services, LLC, a Delaware limited liability company with offices at ARAMARK Tower, 1101 Market Street, Philadelphia PA, 19107 ("ARAMARK").

WITNESSETH:

WHEREAS, the County and ARAMARK entered into an **Operating Agreement – Food Service** on September 6, 2012 for the management of the food operation at Tom Green County Jail (the "Agreement");

WHEREAS, the parties acknowledge the need to address volatility in the cost of food commodities; and

WHEREAS, the parties desire to amend the Agreement as hereinafter set forth, effective September 1, 2014.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below. Capitalized terms used but not defined in this Amendment have the meanings ascribed to such terms in the Agreement:

1. **Term:** Pursuant to Paragraph 6 of the Agreement, the parties agree to extend the term of the Agreement for one year commencing on September 1, 2014 and continuing through August 31, 2015.

2. **Price Adjustment:** In accordance with Paragraph 3A and 3B of the Agreement, the parties agree that the price per meal charged to the County by ARAMARK shall be changed as set forth on Attachment A as a result of changes in the Consumer Price Index and menu modifications. This price shall be effective from September 1, 2014 through August 31, 2015 and shall supersede in all respects the price per meal set forth in Paragraph 3A of the Agreement or in any other prior agreements between the parties.

3. **Effect of Amendment:** Except as specifically set forth herein, all other terms and provisions of the Agreement shall remain unaffected by this Amendment and continue in full force and effect.

Staff price per meal is the same as the inmate price per meal.

Trustee Extra Portion is \$0.25 each.

*The total number of inmate meals served per week is divided by 21 in order to determine the price point on the sliding scale.
