Dear Mr. Jenkins:

The Tom Green County Bail Bond Board is in receipt of a complaint concerning your conduct as a licensed bail bond surety in Tom Green County, Texas. A copy of that complaint is enclosed with this letter.

Upon review of the facts alleged in the complaints, it appears that you may be in violation of one or more of the following sections of the Texas Occupations Code:

- (1) Occupations Code, Sec. 1704.202 which requires you to maintain certain records concerning the bonds that you write, and requires you to make maintain those records at your office location, make them available for inspection by the board or its representative, and maintain them for at least four years after the conclusion of the criminal case for which the bond was given.
- (2) Occupations Code, Sec. 1704.305 which requires you to issue receipts for all monies or other consideration or things of value that you receive, to include specific information on those receipts, to give copies of those receipts to your customers, to maintain copies of those receipts, and to allow the board or its representative to inspect those receipts.
- (3) Occupations Code, Sec. 1704.306 which prohibits falsification of a record that you are required to maintain.

The purpose of this letter is to give you official notice that the board has received this complaint and that the board has determined that it will hold a hearing to receive evidence on this complaint at a meeting to be held **August 4<sup>th</sup>, 2015 at 4:00 p.m.** in the following location: **Tom Green County Commissioners Court Room.**

At that hearing you may attend and be heard, and you may present and cross-examine witnesses if you choose.

At the conclusion of that hearing, the board will make a determination of whether you have violated any or all of the above-listed provisions of the Texas Occupations Code. If the board determines that you have violated any or all of these provisions, the board may suspend or revoke your license to act as a bail bond surety in Tom Green County, Texas or may refuse to renew your current license.
