

**FIRST AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN TOM GREEN  
COUNTY AND THE CITY OF SAN ANGELO FOR SHARED EXPENSE AND OPERATION  
OF THE TDCJ WILDERNESS CAMP**

This Amendment No. 1 (“Amendment”), effective as of the date last signed below (“Effective Date”), amends the interlocal agreement between Tom Green County (“TGC”) and the City of San Angelo, Texas (“COSA”), effective October 1, 2010 (the “Agreement”) for shared expense and operation of the TDCJ Wilderness Camp.

**RECITALS:**

**WHEREAS**, TGC and COSA entered into an interlocal agreement for shared expense and operation of the TDCJ Wilderness Camp effective October 1, 2010; and

**WHEREAS**, under that agreement TGC and COSA determined that there were benefits available to the County, City and non-profit entities through shared operation of the TDCJ Wilderness Camp; and

**WHEREAS**, TGC and COSA agree those benefits continue; and

**WHEREAS**, the current agreement expires on September 30, 2015; and

**WHEREAS**, the operation of the TDCJ Wilderness Camp causes amendments to the original agreement to be necessary.

**NOW, THEREFORE**, in consideration of the mutual benefits and promises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, TGC and COSA agree the interlocal agreement effective October 1, 2010 shall be amended as follows.

**AGREEMENT:**

**PART 1:** “Section 3. **Term**” shall be replaced in its entirety with the following:

“**3. Term.** The term of the Agreement shall be from October 1, 2010 through September 30, 2025.”

**PART 2:** “Section 6. “**Obligations of COSA for Operation and Maintenance.**” shall be amended to read as follows:

“**A. Reimbursement of Expenses.** COSA shall make an annual payment to TGC for the term of this agreement, and an annual payment thereafter on or before December 31 of each year of this agreement. The annual payment due shall be in an amount to reflect 50% of the budgeted expenses of TGC for regular maintenance plus budgeted capital expenses. Emergency repair expenses and any insurance deductibles associated with repairs due to property damage will be reimbursed by COSA for its share (50%) as invoiced by TGC.

**B. Maintenance and Repair of Lift Station.** COSA shall provide preventative maintenance and periodic repairs as needed to the lift station and controls with the operation of the TDCJ Wilderness Camp. This lift

station was purchased, provided, and installed by COSA at the time the TDCJ Wilderness Camp was constructed. In the event the TDJC shall discontinue occupation of the TDCJ Wilderness Camp facility, COSA shall cease responsibility for the on-going maintenance and expense of the lift station.”

**PART 3:** “Section 9. **“Insurance”** shall be amended to read as follows:

“Section 9. **Ownership interest of COSA.** COSA explicitly disowns any ownership interest in the assets and improvements located at the TDCJ Wilderness Camp. As a result, TGC will be the sole insurer for the purposes of this agreement.”

**PART 4:** All other terms and conditions of the Agreement shall remain in full force and effect unless amended and changed by further amendment.

**IN WITNESS WHEREOF,** the parties hereto have caused this **FIRST AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN TOM GREEN COUNTY AND THE CITY OF SAN ANGELO FOR SHARED EXPENSE AND OPERATION OF THE TDJC WILDERNESS CAMP** to be executed by their respective duly authorized officials.


