**MEMORANDUM OF UNDERSTANDING (MOU)
BETWEEN
17TH SECURITY FORCES SQUADRON (17 SFS)
AND
TOM GREEN COUNTY SHERIFF'S DEPARTMENT (TGCSO)
FOR
USE OF 17 SFS FIRING RANGE AND TRAINING FACILITY**

AGREEMENT NUMBER

This is a Memorandum of Understanding (MOU) between the 17 SFS and the TGCSO. When referred to collectively, the 17 SFS and the TGCSO are referred to as the "Parties".

1. PURPOSE: This MOU provides guidance and outlines responsibilities regarding TGCSO use of the 17 SFS Firing Range and Dye Marking Cartridge Training Facility.

2. UNDERSTANDINGS OF THE PARTIES:

2.1. The 17 SFS -

2.1.1. Combat Arms Section (CATM) will schedule Firing Range times for TGCSO upon advance notification.

2.1.1.1. CATM will provide training on the proper use of the Firing Range and expectations of the TGCSO instructors while utilizing the range prior to use.

2.1.2. Training Section will schedule Dye Marking Cartridge Training Facility times for TGCSO upon advance notification.

2.1.2.1. Training Section will provide training on the proper use of the facility and expectations of the TGCSO instructors while utilizing the range prior to use.

2.2. The TGCSO –

2.2.1. Will schedule the use of the Firing Range and/or Dye Marking Cartridge Training Facility in advance with 17 SFS.

2.2.2. Will have one TGCSO certified Trainer on hand to ensure no unsafe acts are conducted on the Firing Range or Dye Marking Cartridge Training Facility.

2.2.3. Will provide all weapons, ammunition and targets needed for TGCSO training.

2.2.4. Will ensure the range or facility and surrounding area is clean after use.

2.2.5. Will be held liable for any injuries.

2.2.6. Will be responsible for any damage to the facilities which occur during their period of occupation.

2.2.7. Will be financially liable for any damage caused by misuse of the range or facility.

3. PERSONNEL: Each Party is responsible for all costs of its personnel, including pay and benefits, support, and travel. Each Party is responsible for supervision and management of its personnel.

4. GENERAL PROVISIONS:

4.1. POINTS OF CONTACT: The following points of contact will be used by the Parties to communicate in the implementation of this MOU. Each Party may change its point of contact upon reasonable notice to the other Party.

4.2. CORRESPONDENCE: All correspondence to be sent and notices to be given pursuant to this MOU will be addressed, if to the 17 SFS, to—

4.3. FUNDS AND MANPOWER: This MOU does not document nor provide for the exchange of funds or manpower between the Parties nor does it make any commitment of funds or resources..

4.4. MODIFICATION OF MOU: This MOU may only be modified by the written agreement of the Parties, duly signed by their authorized representatives, upon 30 days notice of the proposed modification.. This MOU will be reviewed annually on or around the anniversary of its effective date, and triennially in its entirety.

4.5. DISPUTES: Any disputes relating to this MOU will, subject to any applicable law, Executive order, directive, or instruction, be resolved by consultation between the Parties or in accordance with DoDI 4000.19.

4.6. TERMINATION OF UNDERSTANDING: This MOU may be terminated in writing by either Party after one Party notifies the other Party 30 days in advance with the request to terminate.

4.7. TRANSFERABILITY: This MOU is not transferable except with the written consent of the Parties.

4.8. ENTIRE UNDERSTANDING: It is expressly understood and agreed that this MOU embodies the entire understanding between the Parties regarding the MOU's subject matter.

4.9. EFFECTIVE DATE: This MOU takes effect beginning on the day after the last Party signs.

4.10. EXPIRATION DATE: This MOU expires on 9 December 2020 unless otherwise terminated at an earlier date by either Party.

5. CANCELLATION OF PREVIOUS MOU: This MOU cancels and supersedes the previously signed MOU between the same Parties with the same subject.


