**ORDER SETTING CERTAIN SALARIES  
FOR FISCAL YEAR ENDING SEPTEMBER 30, 2016**

Pursuant to Local Government Code §152.905, the District Judges of the 51<sup>st</sup>, 119<sup>th</sup>, 340<sup>th</sup> and 391<sup>st</sup> Judicial District Courts of Texas held a Public Hearing on January 5, 2016, in the Tom Green County Courthouse to address the issue of creating an additional assistant auditor position in the County Auditor's office and setting the amount of compensation for that new position.

A record of the hearing was duly made by Debbie Harris and pursuant to the above statute is ordered transcribed and maintained as a public record.

The District Judges after consultation with the Auditor find that it is necessary that an additional Assistant Auditor be added to the department to insure the department's ability to perform its statutory duties required of the Tom Green Auditor's Office.
