In the interest of protecting the wellbeing of Elected Officials, employees, staff, and the citizens of Tom Green County we have been advised by legal counsel to have Department Heads and Elected Officials acknowledge their willingness to comply with approved Tom Green County policies.

Signifying your acceptance to comply with Tom Green County policies in no way interferes with your autonomy as an Elected Official to administer your office as you deem necessary. It will however enable Tom Green County to conform to appropriate state and federal laws and protect you and the County in possible litigation.

To enable me to comply with state and federal employment laws I agree to adhere to Tom Green County policies as approved by the Tom Green County Commissioners' Court.
