**ORDER SETTING CERTAIN SALARIES

Pursuant to Local Government Code §152.905, the District Judges of the 51st, 119th, 340th and 391st Judicial District Courts of Texas held a Public Hearing on August 18, 2016, in the Tom Green County Courthouse to address the issue of setting the amount of compensation for the Tom Green County Auditor, Tom Green County Assistant Auditors, District Court Reporters, and District Court Bailiffs of these Courts.
