CREDIT AGREEMENT

The Buyer named in (1) of the Credit Application above desires to maintain a credit account with Seller, and agrees to the following terms, charges and conditions:

1. Buyer understands its responsibility at the time of purchase to furnish all information to properly invoice Buyer for any merchandise or service furnished by Seller. Buyer certifies that the information in the Credit application above is true and correct. Buyer agrees to notify Seller by certified mail of any change in ownership in Buyer, and further agrees to be liable for all purchases made at Buyer's location should Buyer fail to comply with said notice. Seller reserves the right to require that a new credit application be filed at any time. Buyer authorizes references and bank named in Credit application above to release information concerning their account.
2. Buyer agrees to pay Seller for all sales on account at Seller's offices at 4500 Industry Park, P.O. Box 2140, San Antonio, Bexar County, Texas. It is agreed that a service charge of 1.5% per month (18% per annum) shall be due and payable on all outstanding balances in Buyer's account which are due and unpaid by the due date. Any partial payments upon the account shall be credited first to the accrued service charges, if any, and then to the unpaid principal balance of the account, unless otherwise decided by Seller.
3. All orders will be shipped Cash on Delivery until credit is approved in writing by the Credit Department of Seller.
4. If the account is placed in the hands of an attorney for collection, or through probate, bankruptcy or other judicial proceeding by any attorney, Buyer agrees and promises to pay a reasonable attorneys' fee for collection, plus any and all other costs and expenses of collection.
5. All returned materials are subject to final approval at office of Seller. Drivers and sales representatives are not authorized to issue credits on returns.
6. The laws of the State of Texas shall govern the interpretation and enforceability of this agreement, and any suit to enforce this agreement shall be brought in Bexar County, Texas. This agreement shall be accepted at the offices of Seller in San Antonio, Texas, and performance by both Buyer and Seller will occur in San Antonio, Texas, unless otherwise agreed in writing. No provision of this agreement shall be modified or limited except as agreed to in writing by the parties hereto. If any provision hereof shall for any reason be or become invalid or unenforceable, the remainder hereof shall not be affected thereby. No waiver of any obligation under this agreement by Seller shall operate as a waiver of any other obligation. The undersigned warrants that he has executed this agreement as an act of and with full authority to bind Buyer.
7. Recognizing that individual credit histories may be a factor in the evaluation of the applicant's credit history, we authorize Labatt Food Service to investigate all references and customary credit information sources, including consumer credit repositories, regarding the credit and financial responsibility of all the principals or officers listed above.



