

**INTERLOCAL AGREEMENT  
BETWEEN  
TOM GREEN COUNTY  
AND  
MHMR SERVICES FOR THE CONCHO VALLEY**

This Interlocal Agreement (hereinafter the "Agreement") is made between the Tom Green County (County) and the MHMR Services for the Concho Valley (MHMRCV) pursuant to Chapter 791 of the Texas Government Code, the Texas Interlocal Cooperation Act.

**Services.** MHMRCV agrees to provide an array of community-based services and supports, such as crisis services, psychiatric evaluation, medication management, provision of medications, psychosocial rehabilitative services, service coordination, and counseling to individuals with mental illness, substance abuse, intellectual & developmental disabilities, and autism.

**Representatives.** The Honorable Steve Floyd, Tom Green County Judge, will serve as the County's representative in all matters relating to this Agreement. John Wyatt, Chief Financial Officer will serve as MHMRCV representative in all matters relating to this Agreement.

**Compensation.** As consideration for the performance by MHMRCV of its obligations under this Agreement, County will pay MHMRCV \$303,314 for fiscal year 2019. MHMRCV agrees that in no event shall any provision of this Agreement be interpreted to obligate the COUNTY beyond the funds approved by its Commissioner's Court for this Agreement.

**Payment.** One-time Payment shall be made.

**Term.** This Agreement shall be in effect September 1, 2018 through August 31, 2019. Either party may terminate this Agreement if the other party fails to comply with term of the Agreement. The terminating party shall notify the other party of the decision to terminate this Agreement at least 60 days before the effective date of termination.

The party in default may avoid termination by correcting the default to the satisfaction of the other party prior to the effective date of termination stated in the notice.

**Entire Agreement.** This Agreement constitutes the entire Agreement between the parties with regard to the subject matter of this Agreement. This Agreement may not be modified except as agreed by the parties in writing, nor may this Agreement be assigned.

**Notices.** Notice under this Agreement shall be in writing and may be delivered by hand, emailed or certified mail, return receipt requested. Notice by hand or email delivery is deemed effective immediately; by certified mail is deemed effective three days after deposit in US Post Office or in a US Mail Box. **Venue.** The parties agree that all disputes that arise out of this Agreement are governed by the laws of the State of Texas and that the venue is proper and lies exclusively in Tom Green

County, Texas.

**Liability.** MHMRCV shall not be liable for any claims, damages, or attorney's fees arising from any negligence or unlawful acts of the County or its commissioners, employees, or agents in relation to this Agreement. County shall not be liable for any claims, damages or attorney's fees arising from any negligence or unlawful acts of MHMRCV or its trustees, employees or agents in relation to this Agreement.

**Relationship of Parties.** MHMRCV is associated with the County only for the purposes and to the extent set forth herein with respect to the performance of this Agreement. Nothing contained herein shall be deemed or construed to create a partnership or joint venture, to create the relationships of an employer-employee or principal-agent, or to otherwise create any liability for either party whatsoever with respect to liabilities and obligations of the other party.
